(a) take any decision that through this Scheme of Delegation is delegated to the Cabinet sub-committee for integrated commissioning,(b) approve city wide health and care strategies in consultation with members of the Health and Wellbeing Board,

Co-ordinating joint marketing of the Humber for inward investment in relevant sectors.

- 17.3 To enable collective decision-making on issues that require sub-regional agreement from the constituent authorities.
- 17.4 To ensure local democratic and financial accountability, working with both the Hull & East Riding and Greater Lincolnshire LEPs and the use of public funding streams which are allocated by Government to the LEPs.
- 17.5 To act as the formal link between local authorities in the Humber on activity relevant to the above themes.
- 17.6 The Committee may delegate the discharge of any of its functions to a subcommittee.
- 17.7 <u>Composition</u>
- 17.8 The Committee shall be comprised of the Leader and one Executive member from each of the following Councils: Hull City Council, East Riding of Yorkshire Council, North East Lincolnshire Council and North Lincolnshire Council.
- 17.9 The Secretariat of and accountable body for the Humber Leadership Board is North East Lincolnshire. Meetings are open to the press and public, and agendas, minutes and papers are published by the Secretariat, in line with the Local Government Transparency Code.

1. Introduction

1.1 The Hull Health and Care (Place Based) Partnership Joint Committee is established as a joint committee of Hull City Council and the North Yorkshire and Humber ICB Board, in accordance with the Constitutions, Standing Orders and Scheme of Delegations of both the Council and the ICB.

1.2 These terms of reference set out the remit, responsibilities, membership and reporting arrangements of this Committee and may only be changed with the approval of the Council and the ICB Board. The Committee has no executive powers, other than those specifically delegated in these terms of reference.

1.3 The ICB is part of the North Yorkshire and Humber Integrated Care System, operates within a set of values that inform the approach in the region:

- Improve outcomes in health and healthcare
- Enhance productivity and value for money
- Tackle inequalities in outcomes, experience and access
- Help the NHS support broader social and economic development

1.4 The Hull Health and Care Partnership has developed a shared Health and Wellbeing Strategy and committed to a Memorandum of Understanding committing to the following shared values:

- Co-ordination at Place
- Intelligence based decisions
- Communities driving change
- Collective accountability

1.5 The Partner Organisations are committed to behaving consistently as leaders and colleagues in ways which model and promote our shared values:

1.6 We have agreed to the following principles of engagement:

- Implement a Place Based Approach to improve the health of our population;
- Act As One to cooperate and establish integrated services in pursuit of our mutual objective to develop a safe and sustainable health and care system;
- Work together openly, transparently, and constructively to deliver high-quality standards of health and care and improved health outcomes, consistently and equitably;
- Achieve Financial sustainability within our shared resources, ensuring cost effectiveness, avoiding duplication and unnecessary costs, delivering efficiency and better value;
- Build upon existing established governance structures where these are working effectively to avoid duplication and inefficient use of resources;
- Align resources to maximise efficiency through the removal of any existing duplication of resource;
- **Develop understanding of the culture and working practices** of the partner organisations so as to build trust and confidence
- **Support the development of economic growth** in the city and sub-region, in accordance with plans for regional workforce development and economic growth¹.
- **Promote citizen engagement** in the co-production of solutions

In furtherance of these objectives we will:

- Brief each other on matters of mutual interest or concern and alert each other to emerging issues which may raise concerns in our respective constituencies;
- Identify and share opportunities for good practice through a transparent and value-formoney partnership;
- Appropriately reflect the content and the spirit of the Memorandum in each other's business plans and strategies;
- Lead the way in achieving advances in health and care;
- Make the commitment of the time and energy necessary to ensure success.
- Hold each other to account within the framework of the values within the Health and Wellbeing Strategy for the city of Hull.

Our clear vision is: Hull will be a healthy and caring city for all ages, where people who are the poorest improve their health the fastest.

1.7 We have also agreed a number of partnership principles:

o We start with people – working with people instead of doing things to them or for them, maximising the assets, strengths and skills of Hull' citizens, carers and workforce. o Have 'Better Conversations' – equipping the workforce with the skills and confidence to focus on what's strong rather than what's wrong through high support, high challenge, and listening to what matters to people

o 'Think Family' – understand and coordinate support around the unique circumstances adults and children live in and the strengths and resources within the family o Think 'Home First' – supporting people to remain or return to their home as soon as it is safe to do so

o We deliver – prioritising actions over words. Using intelligence, every action focuses on what difference we will make to improving outcomes and quality and making best use of the Hull £. o Make decisions based on the outcomes that matter most to people o Jointly invest and commission proportionately more of our resources in first class primary, community and preventative services whilst ensuring that hospital services are funded to also deliver first class care

o Direct our collective resource towards people, communities and groups who need it the most and those focused on keeping people well

o We are Team Hull – working as if we are one organisation, being kind, taking collective responsibility for and following through on what we have agreed. Difficult issues are put on the table, with a high support, high challenge attitude. o Unify diverse services through a common culture

2. Membership

2.1 This part of the terms of reference describes the membership of the Hull Health and Care (Place Based) Partnership ICB Committee. Further information about the criteria for the roles and how they are appointed is documented separately.

2.2 Core membership

2.2.1 The membership of the Committee will be as follows:

Chair: The Chief Executive of Hull City Council

Deputy Chair: NHS Place Director exercising delegated powers on behalf of the Humber and North Yorkshire Integrated Care Board

Local Authority:

Portfolio Holder for Adult Services and Public Health

Hull City Council, Director of Public Health Hull City Council, Director of Children and Families Hull City Council Assistant Director of Adult Social Care (the statutory Director of Adult Social Services (Local Authority Social Services Act 1970) Hull City Council Assistant Director of Housing

Health:

The Chief Executive of the Humber Teaching NHS Foundation Trust The Chief Executive of the Hull University Teaching Hospitals NHS Trust The Chief Executive of the Provider of Community Health Services (City Health Care Partnership Community Interest Company) Representative of the Humber Primary Care Collaborative²

Education:

The Dean of the Faculty of Health Sciences, University of Hull

The Chair of the Hull Learning Partnership³

Health and Social Care Community Champion:

The Contractual Lead for Healthwatch Hull

2.3 ICB officers may request or be requested to attend the meeting when matters concerning their responsibilities are to be discussed or they are presenting a paper.

2.4 Any member of the ICB Board can be in attendance subject to agreement with the Chair.

3.Arrangements for the conduct of business 3.1 Chairing meetings

The meetings will be run by the chair. In the event of the chair of the committee being unable to attend all or part of the meeting, the deputy chair will run the meeting. Should neither the chair nor the deputy chair be in attendance for any part of the meeting the remaining members of the committee should appoint a chair for the meeting.

3.2 Quoracy

No business shall be transacted unless a quorum of 7 members are present. This must include representation from the following as a minimum:

•The Chair or his/her nominated Deputy

- •The ICB Place Director (if different)
- •The Portfolio Holder for Adult Services and Public Health

•Hull City Council, Director of Children and Families or his/her nominated Deputy

•Hull City Council Assistant Director of Adult Social Care (the statutory Director of Adult Social Services (Local Authority Social Services Act 1970) or his/her nominated Deputy

For the sake of clarity:

a)No person can act in more than one capacity when determining the quorum. b)An individual who has been disqualified from participating in a discussion on any matter and/or from voting on any motion by reason of a declaration of a conflict of interest, shall no longer count towards the quorum.

c) Members are normally expected to attend at least 75% of meetings during the year.
d) Members of the Committee may participate in meetings by video link, where available with the prior agreement of the Chair. Participation by any of these means shall be deemed to constitute presence in person at the meeting.

e) With the permission of the person presiding over the meeting, the members may nominate a deputy to attend a meeting of the Committee that they are unable to attend. The deputy must have delegated powers to speak and vote on their behalf. The decision

of the person presiding over the meeting regarding authorisation of nominated deputies is final.

3.3 Voting

a)The Partnership will operate through individual delegations from the partner organisations to the officers who are members of the Partnership. It is expected that decisions will be reached by consensus. This will mean that core members are expected to compromise and demonstrate the behaviours listed within these Terms of Reference. b)If the group cannot reach a consensus on a specific matter, the group will consider inviting an independent facilitator to assist with resolving the specific matter.

c)The Partnership recognises that some decisions may need to be referred to the respective organisational Boards, however, the expectation is that members will gain support for the Board's Annual Programme and any necessary delegations that arise therefrom from their Boards, so as to ensure that they are in a position to make commitments at Partnership meetings.

3.4 Urgent decisions

In the case of urgent decisions and extraordinary circumstances, every attempt will be made for the Committee to meet virtually. Where this is not possible the following will apply:

a) The powers which are delegated to the Committee, may for an urgent decision be exercised by the Chair of the Committee and the ICB Lead Place Lead. The Portfolio Holder for Public Health and Adult Social Care must also be consulted.

b)The exercise of such powers shall be reported to the next formal meetingof the Committee for formal ratification, where the Chair will explain there ason for the action taken, and the ICB Audit Committee for oversight.

3.5 Frequency of meetings

a)The Committee will meet six times a year unless agreed otherwise by the membership. b)Minutes and agreed actions will be circulated within 48 hours of a meeting.

c)The Chair may call an additional meeting at any time by giving not less than 7 calendar days' notice in writing to members of the Committee.

d)One third of the members of the Committee may request the Chair to convene a meeting by notice in writing, specifying the matters which they wish to be considered at the meeting. If the Chair refuses, or fails, to call a meeting within seven calendar days of such a request being presented, the Committee members signing the requisition may call a meeting by giving not less than 14 calendar days' notice in writing to all members of the Committee specifying the matters to be considered at the meeting.

e) In emergency situations the Chair may call a meeting with two days' notice by setting out the reason for the urgency and the decision to be taken

3.6 Agendas

a) All members will be able to propose agenda items for discussion;

- b) The Agendas will be separated into two parts:
 - a. Formal Public Business;
 - b. Exempt Items (in private)

This will include the opportunity for informal discussion of items with a view to the development of future Formal Business items

c) A public notice of the time and place of the meeting and how to access the meeting shall be given by posting it at the offices of Hull City Council and electronically at least seven calendar days before the meeting or, if the meeting is convened at shorter notice, then at the time it is convened.

d) Papers will be prepared by the member organisation or organisations advancing a proposal in accordance with a template that meets the requirements of governance of the commissioning organisations;

e)All supporting documentation and agenda items will be circulated to members at the same time;

3.7 Admission of the press and public

Meetings of the Committee will be open to the public.

The Committee may resolve to exclude the public from a meeting or part of a meeting where it would be prejudicial to the public interest by reason of the confidential nature of the business to be transacted or for other special reasons stated in the resolution and arising from the nature of that business or of the proceedings.

The chair of the meeting shall give such directions as he/she thinks fit with regard to the arrangements for meetings and accommodation of the public and representatives of the press such as to ensure that the Committee's business shall be conducted without interruption and disruption.
