



PRIVATE DRIVEWAY -Permeable paving to parking bays. Refer to details by Mason Clark Associates.

ROTARY DRYER to rear garden.

TURF -

Turfing to garden areas 150mm topsoil certified from a 'clean' source. Refer to any site remediation requirements. Gardens to be rotavated and stone picked prior to turfing. Provide mowing strip (300mm) to turfed areas adjacent walls & fences.



PCC PAVING FLAGS -

All main access paths to be 900mm wide. Paths around perimeter of dwellings to be 900mm wide. Cross fall max 1:40.

LEVEL ACCESS LANDING -

Parking - 16nr in-curtilage spaces (2nr per property)

1200mm x 1200mm to principal entrance to each property. Proprietary drainage channel to door threshold.

PROPOSED TREES -

species and locations to be agreed with HCC. Policy 45 requires that 3nr new trees are planted for each new dwelling (24 total). Where possible, these have been shown as part of the development. Any shortfall in numbers will need to be planted off-site in agreement with HCC.

1800mm high close boarded timber fencing with concrete posts. Height measured from highest adjacent ground level and stepped as appropriate. NB cases of retaining to be supported by gravel boards or flag on edge.

REAR DIVISIONAL HIT AND MISS TIMBER FENCING 1800mm high x 1800mm long hit and miss timber privacy panel, reducing in height to 1500mm with concrete posts. Height measured from highest adjacent ground level and stepped as appropriate. NB cases of retaining to be supported by gravel boards.

PLOTS AND BACK EDGE OF FOOTPATH 900mm high decorative galvanised hoop top metal railings with black painted finish to boundary.

1800mm high FLB timber gate with galvanised ironmongery and locking facility.
