

# NOTICE OF ELECTION

## Police and Crime Commissioner election for the Humberside Police Area

1. An election is to be held for a Police and Crime Commissioner for the Humberside Police Area.
2. Nomination papers can be obtained from the office of the Police Area Returning Officer, Electoral Services Team, County Hall, Cross Street, Beverley, East Riding of Yorkshire, HU17 9BA during the times stated below.
3. Nomination papers must be delivered **by hand** to the Police Area Returning Officer at Electoral Services Office, County Hall, Cross Street, Beverley, East Riding of Yorkshire, HU17 9BA between 10am and 4pm on any working day after publication of this notice but no later than 5 April 2024.
4. If the election is contested the poll will take place on 2 May 2024.
5. Applications to register to vote must reach the relevant Electoral Registration Officer by 12 midnight on 16 April 2024. Applications can be made online: **<https://www.gov.uk/register-to-vote>**.
6. The £5,000 deposit can be paid by legal tender or by means of a banker's draft from a drawer which carries on business as a banker in the United Kingdom. Deposit payments will also be accepted using BACS electronic transfer of funds and debit or credit card.
7. Applications, amendments or cancellations of postal votes must reach the relevant Electoral Registration Officer by 5pm on 17 April 2024.
8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on 24 April 2024. 9. Applications to vote by proxy at this election must reach the relevant Electoral Registration Officer by 5pm on 24 April 2024.
10. Applications to vote by emergency proxy at this election must reach the relevant Electoral Registration Officer by 5pm on 2 May 2024.
