# **Housing Support Grant**

## What we use your information for

The Housing Support Grant (HSG) is a government funded programme that provides funding to local authorities for people who are being supported for their drug and alcohol use and require support for their housing. We use personal information to monitor the effectiveness of support provided through the Housing Support Grant and to provide data to the Department of Health and Social Care (DHSC), who administer the Grant.

### What information we hold and use

The types of information we hold and process includes;

- names
- dates of Birth and National Insurance Number
- · accommodation status
- issues with your housing
- health and welfare information

## Legal basis for processing your personal data

Information is processed in the performance of a task carried out in the public interest and in the exercise of official authority vested in us. Special category data relating to health and welfare is processed only where necessary for reasons of substantial public interest on the basis of Union or Member State law or for the establishment, exercise or defence of legal claims or whenever courts are acting in their judicial capacity.

### How we collect information

Information is collected from;

- Other Council Departments
- Professionals at other organisations delivering support funded by the Housing Support Grant

It is collected using forms, email, and from details held on computer systems

### Who we share information with

We do not make your personal information available to companies for marketing purposes. Information is shared with other Council Departments and external organisations where necessary for the monitoring of delivery and use of the Grant funding provided to us by the DHSC.

# Security and retention of your personal data

Personal data is stored within Hull City Council's secure computer network and offices that have controlled access. It is retained for as long as there is a business and legislative need for it, normally for the current year, plus 6 years following the end of interest.

## What rights you have

You have -

- a 'Right of Access' to see the information we hold about you
- a 'Right to Rectification' where you believe information we hold about you is incorrect or incomplete
- a 'Right to Restrict processing' and a 'Right to object' to processing where certain circumstances apply

To exercise these rights you need to contact us as detailed below. For rectification, restriction or objection you need to provide the reasons for you request.

Your personal information is not processed for individual automated decision making, or used for profiling of individuals for marketing purposes.
