





# ST MARY'S COLLEGE, VOLUNTARY CATHOLIC ACADEMY

## ADMISSION POLICY 2026-27

St Mary's College was founded by the Catholic church to provide education for children of Catholic families. Whenever there are more applications than places available, priority will always be given to Catholic children in accordance with the oversubscription criteria listed below. The school is conducted by St Cuthbert's Roman Catholic Academy Trust (SCRCAT) as part of the Catholic Church in accordance with its trust deed and articles of association and seeks at all times to be a witness to Our Lord Jesus Christ.

As a Catholic academy, we aim to provide a Catholic education for all our pupils. At a Catholic academy, Catholic doctrine and practice permeate every aspect of the academy's activity. It is essential that the Catholic character of the academy's education be fully supported by all families in the academy. We therefore hope that all parents will give their full, unreserved, and positive support for the aims and ethos of the academy. This does not affect the right of an applicant who is not Catholic to apply for and be admitted to a place at the school in accordance with the admission arrangements.

SCRCAT is the admission authority and has responsibility for admissions to this school. The local authority undertakes the co-ordination of admission arrangements during the normal admission round. The Trust Board has set its published admission number (PAN) at 360 pupils to Year 7 in the school year which begins in September 2026.

The admission authority (SCRCAT) will, where logistically possible, admit twins and all siblings from multiple births where one of the children is the last ranked within the school's PAN.

#### Admission to the Sixth Form

For advanced courses, prospective students must have achieved the respective minimum entry requirements. Any additional and specific entry requirements for individual subjects are available on request.

Students of other religious faiths and none are welcome to apply as long as they are supportive of our Christian ethos. Details of this are in the registration documents and learning agreement which all students sign when enrolling in the Sixth Form.

#### Pupils with an Education, Health and Care Plan (see note 1)

The admission of pupils with an Education, Health and Care Plan is dealt with by a completely separate procedure. Children with an Education, Health and Care Plan that names the academy must be admitted. Where this takes place before the allocation of places under these arrangements this will reduce the number of places available to other children.

The exception to this is where admitting the child would be incompatible with the provision of efficient education for other children, and where no reasonable steps may be made to secure compatibility. In deciding whether a child's inclusion

would be incompatible with the efficient education of other children, the Trust shall have regard to the relevant guidance issued by the Secretary of State to maintained schools.

In the event of any disagreement between the academy and the Local Authority over the proposed naming of the academy in an EHC Plan, the academy may ask the Secretary of State to determine whether the academy should be named. The Secretary of state's determination shall, subject only to any right of appeal, be final.

# **Oversubscription Criteria**

## At any time where there are more applications for places than the number of places available, places will be offered according to the following order of priority:

- 1. Catholic looked after and previously looked after children (see notes 2&3)
- 2. Other Catholic children (see note 3)
- 3. Other looked after and previously looked after children (see note 2)
- 4. Catechumens and members of an Eastern Christian Church. (see notes 5&6)
- 5. Children who have a sibling at St Mary's College (see note 9)
- 6. Children of staff (see note 10)
- 7. Children with a proven aptitude in Music (see note 11)
- 8. Children of other Christian denominations from our named feeder academies (see notes 4 & 7)
- 9. Children of other Christian denominations and children of other faiths whose membership is evidenced by a minister of religion or other religious leader (see notes 7 & 8)
- 10. Other children from our named feeder academies (see note 4)
- 11. Any other children.

Where evidence is provided at the time of application of an exceptional social, medical, or pastoral need of the child which can be most appropriately met at this academy, the application will be placed at the top of the category in which the application is made (see note 12)

## Tie Break

Priority will be given to children living closest to the academy determined by the shortest distance. Distance will be measured [by the shortest walking route] from the front door of the child's home address (including flats) to the main entrance of the academy, [using the Local Authority's computerised measuring system], with those living closer to the academy receiving the higher priority.

## **Application Procedures and Timetable**

To apply for a place at this academy in the normal admission round, you must complete a Common Application Form available from the local authority in which you live. You are also requested to complete the Supplementary Information Form attached to this policy if you wish to apply under oversubscription criteria 1,2,4,5,6,7,8&9. The Supplementary Information Form should be returned to Admissions Department, St. Mary's College, Cranbrook Avenue, Hull. HU6 7TN.

You will be advised of the outcome of your application on 1 March or the next working day, by the local authority on our behalf. If you are unsuccessful (unless your

child gained a place at a school/academy you ranked higher) and you have the right of appeal to an independent appeal panel.

If you do not provide the information required in the SIF and return it by the closing date, together with all supporting documentation, your child will not be placed in criteria 1,2,4,6,7,8&9 and this is likely to affect your child's chance of being offered a place.

All applications which are submitted on time will be considered at the same time and after the closing date for admissions which is 31 October 2026, set by the local authority.

#### Late Applications

Late applications will be administered in accordance with your home Local Authority Secondary Co-ordinated Admissions Scheme. You are encouraged to ensure that your application is received on time.

#### Admission of Children Outside their Normal Age Group

Parents may make a request to St Mary's College for their child to be educated outside of their normal age group. Any request for a child to be admitted outside the normal age group for the child should be made as soon as possible and before making an application for a school place. Where possible, parents should seek to make the request to St Mary's College before the child's normal age group admissions round closes.

St Mary's College admissions authority will make its decision about the request based on the circumstances of each case and in the best interests of the child. This will include taking account of:

- the parents' views;
- information about the child's academic, social, and emotional development;
- where relevant, the child's medical history and the views of a medical professional;
- whether the child has previously been educated out of their normal age group;
- whether the child would naturally have fallen into a lower age group if they had not been born prematurely; and
- the views of the Head Teacher

when considering the request.

When providing its decision, St Mary's College will clearly set out its reasons for the decision and if possible ensure that the parents receive the response before the normal age group admissions round closes.

Where a request is agreed, parents may submit an admissions application. St Mary's College will then consider the admissions request in accordance with its standard Admissions Policy, including the application of any Oversubscription Criteria.

Where a request is refused, parents may continue with any admissions application for the child's normal age group.

If parents are unhappy with the decision and/or reasons given, they may in the first instance raise a complaint with St Mary's College admissions authority.

## Waiting Lists

In addition to their right of appeal, unsuccessful children will be offered the opportunity to be placed on a waiting list. This waiting list will be maintained in order of the oversubscription criteria set out above and **not** in the order in which applications are received or added to the list. Waiting lists for admission will operate throughout the academy year. The waiting list will be held open until the last day of the Summer Term 2027.

Inclusion on the academy's waiting list does not mean that a place will eventually become available.

#### **In-Year Applications**

An application can be made for a place for a child at any time outside the normal admission round and the child will be admitted where there are available places. Application should be made through your Local Authority. Where\_there are places available but more applications than places, the published oversubscription criteria, as set out above, will be applied.

You will be advised of the outcome of your application in writing, and you have the right of appeal to an independent appeal panel.

#### Fair Access Protocol

The academy is committed to taking its fair share of children who are vulnerable and/or hard to place, as set out in locally agreed protocols. Accordingly, outside the normal admission round the admission authority is empowered to give absolute priority to a child where admission is requested under any locally agreed protocol. The admission authority has this power even where admitting the child would mean exceeding the published admission number (PAN).

The admission authority reserves the right to withdraw the offer of a place or, where the child is already attending the academy the place itself, where it is satisfied that the offer or the place was obtained by deception.

## Notes (these notes form part of the oversubscription criteria)

- 1. An Education, Health and Care Plan is a plan made by the local authority under section 37 of the Children and Families Act 2014 specifying the special educational provision required for a child.
- 2. A 'looked after child' has the same meaning as in section 22(1) of the Children Act 1989 and means any child who is (a) in the care of a local authority or (b) being provided with accommodation by them in the exercise of their social services functions (e.g., children with foster parents) at the time of making application to the academy.

A 'previously looked after child' is a child who was looked after but ceased to be so because he or she was adopted, or became subject to a child arrangements order, or special guardianship order. Included in this definition are those children who appear (to the admission authority) to have been in state care outside of England and who ceased to be in state care as a result of being adopted.

3. 'Catholic' means a member of a Church in full communion with the See of Rome. This includes the Eastern Catholic Churches. This will normally be evidenced by a certificate of baptism in a Catholic Church or a certificate of reception into the full communion of the Catholic Church. For the purposes of this policy, it includes a looked after child living with a family where at least one of the parents is Catholic.

For a child to be treated as Catholic, evidence of baptism or reception into the Church will be required. Those who have difficulty obtaining written evidence of baptism should contact their Parish Priest who, after consulting with the Diocese, will decide how the question of baptism is to be resolved and how written evidence is to be produced in accordance with the laws of the Church.

- 4. Catholic Feeder this refers to the Roman Catholic Primary academies within the St Cuthbert's RC Academy Trust.
- 5. 'catechumen' means a member of the catechumenate of a Catholic Church. This will normally be evidenced by a certificate of reception into the order of catechumens.
- 6. Eastern Christian Church' includes Orthodox Churches and is normally evidenced by a certificate of baptism or reception from the authorities of that Church.
- 7. "children of other Christian denominations" means children who belong to other churches and ecclesial communities which, acknowledge God's revelation in Christ, confess the Lord Jesus Christ as God and Saviour according to the Scriptures, and, in obedience to God's will and in the power of the Holy Spirit commit themselves: to seek a deepening of their communion with Christ and with one another in the Church, which is His body; and to fulfil their mission to proclaim the Gospel by common witness and service in the world to the glory of the one God, Father, Son and Holy Spirit. An ecclesial community which on principle has no credal statements in its tradition, is included if it manifests faith in Christ as witnessed to in the Scriptures and is committed to working in the spirit of the above.

All members of Churches Together in England and CYTÛN are deemed to be included in the above definition, as are all other churches and ecclesial communities that are in membership of any local Churches Together Group (by whatever title) on the above basis.

- 8. "children of other faiths" means children who are members of a religious community that does not fall within the definition of 'other Christian denominations' at 7 above and which falls within the definition of a religion for the purposes of charity law. The Charities Act 2011 defines religion to include:
  - A religion which involves belief in more than one God, and
  - A religion which does not involve belief in a God.

Case law has identified certain characteristics which describe the meaning of religion for the purposes of charity law, which are characterised by a belief in a supreme being and an expression of belief in that supreme being through worship.

9. 'brother or sister' includes:

Children with the same natural parents living at the same address.

Children with the same natural parents living at different addresses.

The definition of sibling does not include families sharing a house.

A child's "home address" refers to the address where the child usually lives with a parent or carer and will be the address provided in the Common Application Form ("CAF"). Where parents have shared responsibility for a child, and the child lives for part of the week with each parent, the home address will be the address given in the CAF, provided that the child resides at that address for any part of the school week.

- 10. Children of Staff children / child with a parent or carer who has been a permanent member of staff (teaching or support) within the academy for 2 years or more at the time at which the application is made. Children with a parent or carer who was recruited to fill a vacant post for which there is a demonstrable skills shortage. This does not include staff who work on the school site for other employers.
- 11. Applicants seeking admission under the aptitude in music criteria, will be asked to register on-line via a Microsoft form published on our website. Access to the form will be available via our website in September along with full details of the test requirements.
  - a. A deadline for registering will be set by St Mary's College.
  - b. After this deadline, applicants will be invited into the College to take the test.
  - c. The test will take place before the Local Authority deadline of 31 October.
  - d. Applicants will be notified of the outcome before the Local Authority deadline of 31 October to allow time to make an informed choice of school selection.
  - e. Applicants who pass, will be put forward for selection under "The Proven Aptitude in Music" selection of our admission arrangements oversubscription criteria.
  - f. Progression into this category, at this stage, does not guarantee a place. The admission authority can only allocate up to 10% of the total admissions intake on the basis of aptitude in music.
- 12. To demonstrate an exceptional social, medical, or pastoral need of the child which can be most appropriately met at this school, the admission authority will require compelling written evidence from an appropriate professional, such as social worker, doctor, or priest.
